

BAY-DELTA TOUR 2023 FIELD TRIP - MAY 17-19

This tour travels deep into California's water hub and traverses the Sacramento-San Joaquin Delta, a 720,000-acre network of islands and canals that supports the state's water system and is California's most crucial water and ecological resource. The tour will make its way to San Francisco Bay and includes a ferry ride.

Water from Northern California flows through the Delta and provides drinking water for more than 27 million Californians and irrigation to about 3 million acres of farmland that contribute to the state's \$54 billion agricultural industry.



Planned stops include the Delta Cross Channel, the Bay Model in Sausalito, Los Vaqueros
Reservoir and Suisun Marsh. Issues to be discussed include Delta planning initiatives, the
proposed tunnel project, water project operations, fish passage, ecosystem restoration, levees and flood management, Delta agriculture, storage, and drinking water guality and water supply reliability.



This 3-day, 2-night tour features experts who will discuss the issues and controversies with this important resource, farmers who grow produce and environmentalists who are trying to bolster declining fish populations.

Tour Start & End Point:

The tour starts at 7:30 a.m. on May 17 and ends at 6:30 p.m. on May 19 at the Water Education Foundation office, <u>2151</u> River Plaza Drive, Suite 205, Sacramento, CA. Free parking is available.

The tour includes overnight stays in Stockton and Walnut Creek which are arranged by the Foundation and covered by the registration fee.

The <u>Courtyard Sacramento Airport Natomas</u> is next door to the Water Education Foundation and also offers a shuttle to/from Sacramento International Airport (SMF). We have a discounted room rate arranged there and self-pay booking options are provided upon registration for the tour.

Pricing Details:

General – \$999 (one person, single-occupancy room)

Fee includes all tour meals, transportation, materials, snacks and hotel accommodations once the tour begins Wednesday. Meals covered by the registration fee include lunch on Wednesday through lunch on Friday. Participants are responsible for their own transportation to and from the tour's beginning and end point.

A limited amount of scholarship funding is available to pay for a portion of the tour. Scholarships are awarded based on a few factors, including:

- · Financial need
- · Reason for scholarship request
- · How the education & experience will be used after the tour

COVID-19 Policy:

The Foundation continues to monitor developments with COVID-19. Precautions will be implemented during the tour including enhanced sanitation protocols and an itinerary that maximizes use of outdoor/open-air spaces when feasible.

Despite these mitigating circumstances, an inherent risk of exposure to COVID-19 exists in any place where people gather. All participants should consider their personal choices around harm reduction and risk tolerance in the face of current variants and the likelihood of additional variants emerging in the future.

Acceptance of an assumption of risk waiver is required during registration for the tour.

We ask participants not to attend if, within 72 hours of the tour start date, they have experienced symptoms of COVID-19 (e.g., a fever of 100.4F or higher, cough, shortness of breath or difficulty breathing, chills, repeated shaking muscle pain/achiness, headache, sore throat, loss of taste or smell, nasal congestion, runny nose, vomiting, diarrhea, fatigue or any other symptoms associated with COVID-19 identified by the CDC).

If a participant tests positive or is exposed to someone who tests positive for COVID-19 within 5 days of the tour start date, they must provide proof of a negative COVID-19 test result within 72 hours of the tour start date regardless of their vaccination status.

Cancellation & Refund Policy:

Deadline to cancel and receive a refund is three weeks prior to the first day of the tour due to hotel, meal and transportation commitments. Substitutions are allowed up to five business days before the tour. Eventbrite fees are nonrefundable and the remaining amount may be subject to an additional 10% processing fee.

We recognize that unexpected conflicts with our tours can occur from time to time. The Water Education Foundation recommends you consider arranging travel insurance from a provider of your choice soon after tour registration to protect against such unfortunate events.

Continuing Education Credits:

California Legislature Advances Three Water Rights Bills to Appropriations Committees

Two water rights bills in which ACWA is leading a large coalition to oppose advanced out of committees Tuesday despite several ACWA members and others in the coalition, testifying to urge "No" votes. A third water rights bill advanced last week.

AB 460 (Bauer-Kahan) passed out of the Assembly Judiciary Committee with a vote of 7-2-2 and moves to the Assembly Appropriations Committee. Brian Poulson, General Counsel for El Dorado Irrigation District and Chair of ACWA's State Legislative Committee, provided lead testimony in opposition to the bill alongside Jennifer Pierre, General Manager of the State Water Contractors. More than 20 other people testified in opposition to the bill.

"(AB 460) would apply to illegal and legal diversions, substantially broadening the State Water Board's authority beyond what is necessary to enforce the water rights system which would be to the detriment of all water users," Pierre testified. "A complete dismantling of the water rights system, which is what this bill would result in, will paralyze these agencies from making these urgent and necessary investments (in water infrastructure projects)."

SB 389 (Allen) passed out of the Senate Natural Resources and Water Committee and will next moves to the Senate Appropriations Committee. While the bill narrowly advanced out of committee on a 6-3-2 vote, multiple committee members raised concerns with the bill. In particular, committee members questioned the need to hand the State Water Resources Control Board sweeping authority to investigate lawabiding water right holders.

AB 1337 (Wicks) passed out of the Assembly Water, Parks, and Wildlife Committee on April 18 with amendments and will also be heard in the Assembly Appropriations Committee.

ACWA has issued Legislative Alerts urging members to join the coalition and contact local legislators to share their opposition. Talking points are available to assist in those conversations.

Background

ACWA's State Legislative Committee has taken an oppose position on all three bills that threaten to undermine the basic foundation of water management and water delivery in California. ACWA staff is making it a top priority to stop them and is leading a coalition of water and business/economic interests in opposition of the following bills.

<u>AB 460</u> (Bauer-Kahan) would grant the State Water Resources Control Board new and sweeping authority to issue interim relief orders against water diverters and users. Additionally, these orders could be issued without holding a hearing in which water right holders could defend their actions.

The bill would also authorize the State Water Board to enforce the orders by imposing onerous and costly requirements on water users. This could include curtailing diversions, imposing new minimum streamflow requirements, directing reservoir operations, requiring the diverter to conduct technical studies, and more.

<u>AB 1337</u> (Wicks) would authorize the State Water Board to issue curtailment orders against all water right holders and during any water year type. This would have the potential to significantly impact the certainty and availability of water supplies.

<u>SB 389</u> (Allen) would authorize the State Water Board to investigate and determine the scope and validity of any water right claim. In any proceeding to evaluate the basis of a water right, the water right holder would have the burden of proving the basis of the right. ACWA has serious concerns with authorizing the State Water Board to drag water right holders before the Board to prove their claims.
